Matters Arising The meeting noted the disappointing response to the letter pointing out the anomalies in introducing a smoking ban on public pavements where food is served. (On behalf of the CC, the Chairman had written to South Ayrshire Council requesting a moratorium over the Summer with regard to the ban on smoking in public places, until there had been some consultation with the Community Council, café owners and members of the public.)
